Dr. Matthew J. Fien graduated from Columbia University College of Dental Medicine in 2006. He then received his specialty training in Periodontics from Nova Southeastern University and his diplomate status from the American Board of Periodontology and Implant Dentistry in 2009. Dr. Fien has completed a number of research projects which have led to his work being published in various dental journals, including the JOP, the JMOS, the CCED, and the IJPRD. He lectures throughout the country on bone grafting techniques and all aspects of implant dentistry. He developed a hands-on guided bone regeneration course, which he teaches several times throughout the year. Dr. Fien enjoys lecturing at Nova SE University and several other post graduate dental programs throughout the country. He is an active member of the AAP, AO, and the SAP and maintains a private practice in Fort Lauderdale, Florida, limited to Periodontics and Implant Dentistry.

Dr. Israel Puterman, originally from Montreal, CDN received his DMD from Boston University in 2002. Attended Loma Linda University, where he received two residency certificates one in Implant Dentistry and Periodontics, as well as a Master of Science in Dentistry. As part of his dual residency training, he obtained expertise in the surgical, prosthetic and laboratory phases of complex implant cases. Limiting his private practice in the Washington DC to the surgical fields of Implant Dentistry, Bone and Soft Tissue Regeneration and Periodontics using 3D microscopy. Dr. Puterman is a published author in various journals, including the JPD and the JOP. He is the recipient of awards by the CA Society of Periodontists, the WSP, the AAID and has been honored by colleagues as a Best of Washingtonian Periodontist since 2011. He leads a Spear Study Club and runs a leading Instagram account, @implantsdc, demonstrating the various complexities related to implant and periodontal surgery. Dr. Puterman also co-founded the popular Surgical Influence, an educational platform focusing on surgical training courses.



Advancements in Materials, Techniques, & Protocols to Improve Treatment Outcomes

Course Description

The purpose of this course is to present contemporary techniques that can be utilized to improve clinical outcome in periodontal surgery. A comparison of workflows for various procedures will be reviewed. The topics that will be discussed include Guided Bone Regeneration, Soft Tissue Augmentation, and Implant Placement for simple as well as complex cases.

Course Objectives

- Advancements in digital Implant dentistry will be reviewed and compared to traditional analog techniques. Multiple workflows for treatment of simple as well as complex implant cases will be presented to illustrate the wide variety of treatment options that we have available to us.
- Advancements in bone grafting materials and techniques will be presented to highlight the use of resorbable membranes, various stabilization techniques, and the use of biologics to enhance the handling of our regenerative materials and ultimately improve predictability.
- Advancement in Soft Tissue Grafting protocols will be reviewed and compared to various commercially available soft tissue alternatives currently on the market. Applicable techniques, handling advice, and case selection for the use of these soft tissue alternatives will be presented.
